CARTOGRAPHY OF CULTURAL MARGINALITY: SITUATING DALIT WRITINGS IN INDIA

#### CALL FOR PAPERS

The caste system is one of the most brutal forms of hierarchical social organization and caste-based discrimination affects over 250 million people in South Asia and across the globe. Dalits, that is, the "former Untouchables" are on the lowest rung of the Hindu social structure and South Asian society. Despite some increased legal protections in caste-affected countries within and without South Asia, the Dalit community continues to face indignities ranging from daily humiliations, to extreme poverty and servitude, to violence and murder. As of 2020, every 10 minutes a crime is committed against a Dalit and every day 8 Dalit women are subjected to rape in India. Crimes against the Dalits include murder, lynching, massacre, suicide, social ostracization, economic exploitation, and sexual abuse. Dalits still remain socially excluded from the benefits that accrued to a large number of many communities. The social and economic disparities have deteriorated over years. Dalits are chronically excluded from economic, cultural and political benefits. The ambit explains that the dearth of opportunities plaguing the socially excluded communities is in its worst possible from the social institution of 'Caste'. According to the Census of India (2011) Dalits constitute 16.7 percent of Indian population, yet their socioeconomic and political status sets apart from the other upper castes and backward classes. Caste discrimination against Dalits is strongly pronounced. India has been independent for the last sixty seven years and Dalits still are living below the line of poverty with impoverished conditions. Faced with the atrocities within the Hindu social order, at the very outset Dalits in India face a challenge whether to remain within the Hindu folds or convert to Buddhism or to any other religion For the Dalit community, the entrenched caste system sanctions a massive denial of citizenship and fundamental rights which others enjoy under the constitutions of countries in South Asia. Dalit literature plays a crucial role in the process of recovering the cultural memory of the Dalit past and in uncovering the social-cultural subjugation of Dalits. It is during this transformative period of Dalit social, cultural and political upsurge for social equality and political rights that Dalit literature as genre has emerged in India. The struggle of Dalit Indians is inspired by Ambedkar and his vision of liberation from the caste-based oppression and the struggle of Afro-Americans is inspired by King and his vision of liberation from the race-based oppression. The greatest similarity between Dalit and Black struggles is their aim that is to strive for social equality. It means Ambedkar is right in saying that every caste is a nation in itself in India. Social integration precedes national integration. Hence, Ambedkar visualised sociocultural revolution as the primary condition for a political revolution that binds all communities in the society into one strong, and vibrant democratic nation on equal footing. Dalit thinkers like Phuley and Ambedkar laid the groundwork in modern India for a more inclusive society. They conceptualised the social narrative to redefine social borders. It is said that the civil rights movement of Afro-Americans in America made an impact over Dalit movement in India particularly after Ambedkar and produced a radical movement known as Dalit Panthers movement in the 1970s on the lines of the movement led by Black Panthers Party of America.

The proposed one day seminar will explore critical issues faced by the Dalit community, with a focus on the intersecting nature of gender, religion, and caste-based discrimination. This broad theme is based upon the following issues that participants might be interested in specifically exploring (in the broader context described above).
